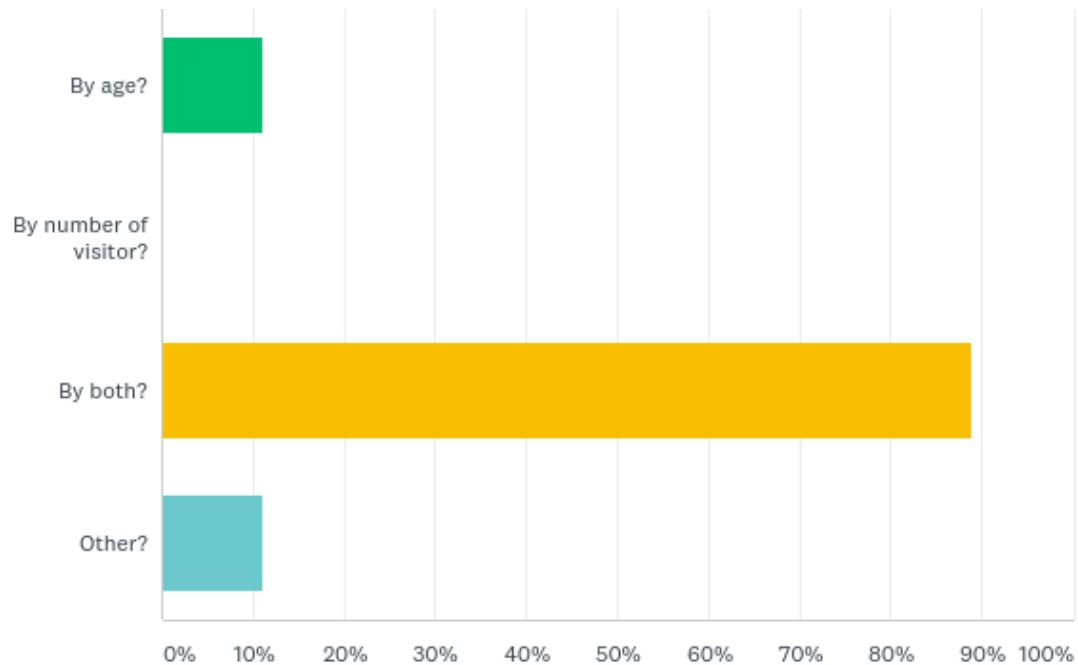

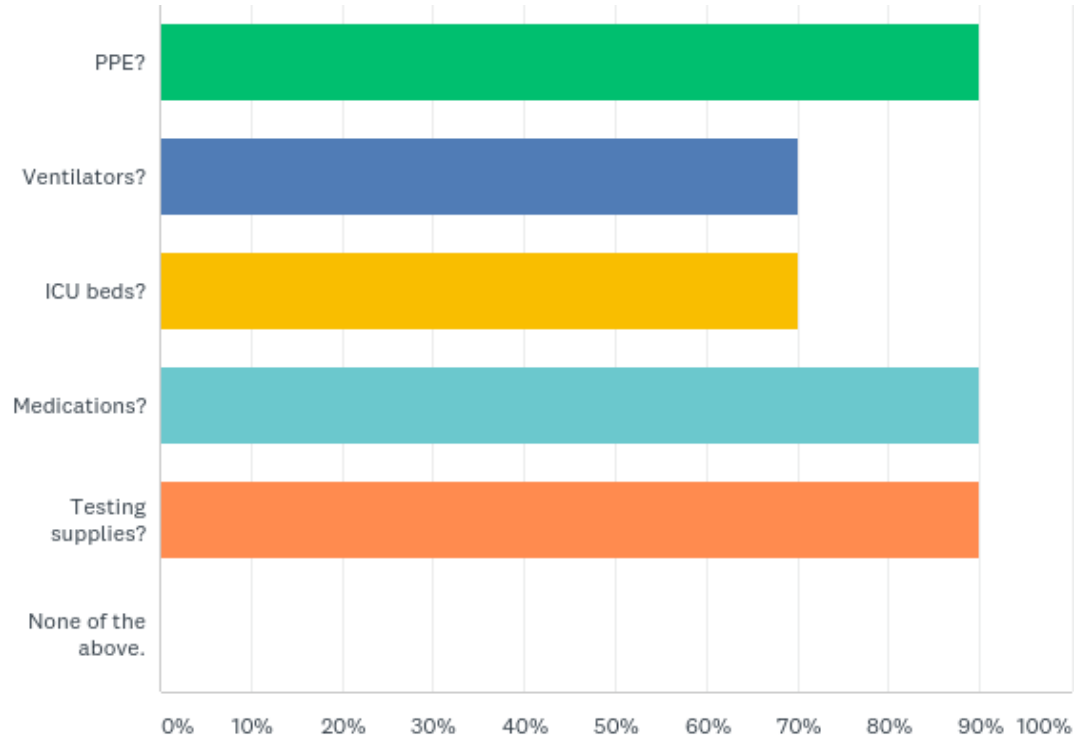

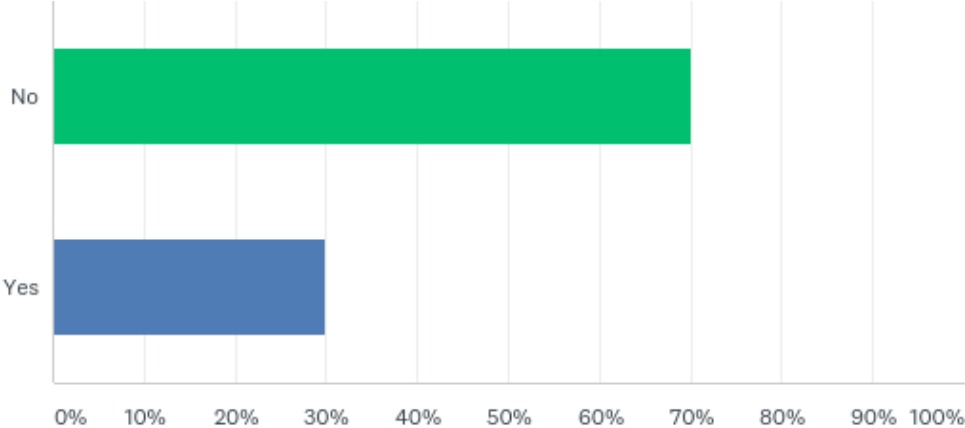

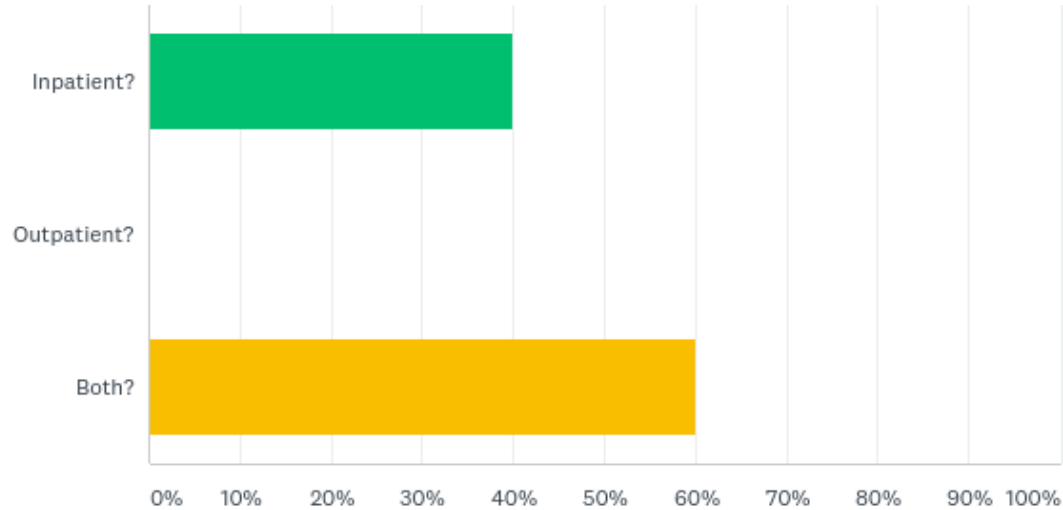

How are you handling influenza ED / Inpatient surge?

- We have opened up a separate area in our ED to take more stable patients with ILI symptoms to be seen quickly there (tested & discharged)
- CDPH Flex Program
- Mary Birch only has a Triage. We have had an uptick with pregnant flu patients, but not a "surge". Our seriously ill pregnant flu patients are admitted to Sharp Memorial.
- Extra staffing in the Emergency Room
- Since we are LTC and we have 2 floors for residents/patients, we held admissions until the criteria of CDPH/CDC were met and the county epidemiologist was contacted and had given us a go on admissions.
- Cases that do not require admission are seen but discharged with treatment
- CDPH-sanctioned flu surge tent
- Opened up more units that do not typically hold patients (critical care, acute, and PCU), opened up old ER area for use, actively discontinuing isolation precautions to aid in patient movement
- mask, test and triage
- Inpatients: we have an overflow surge unit; working with staff on flow to get admissions up from ED quicker; cohorting like illnesses when no private rooms available; facilitate early discharges ED: opened evening flu clinic to see influenza patient presenting to ED for treatment Urgent Cares: Extended hours to accommodate increase volume/decrease volume in ED
